SUBMISSION OF APPLICATION FOR RENEWAL OF PENURY, ORPHAN & 100% DISABLED CHILD GRANT BY ENTITLED TO SEEK FINANCIAL ASSISTANCE FROM AFFDF

1. Please refer to this office letter No. 195/Welfare/Misc/2024-25 dated 07 Feb 2024 (copy attached), forwarded to all RSBs pertaining to timely submission of applications for the following schemes:-

- (a) Financial Assistance Penury Renewal
- (b) Financial Assistance Orphan Renewal
- (c) Financial Assistance 100% Disabled Child Renewal


2. Vide Para 1 of letter under reference, it was reiterated that for renewal of the above schemes, the applicants are required to upload their life certificates online on KSB Website www.online.ksb.gov.in between **01st Dec and 31st Mar** of the current FY. It was also reiterated that life certificates will not be accepted manually.

3. **Advisory for Renewal of Penury, Orphan & 100% Disabled Child Grant.** The following is reiterated:-

- (a) Applicants whose initial applications have already been sanctioned in FY 2023-24 & earlier will be entitled to apply for renewal of the above schemes between 1st Dec 2024 & 31st Mar 2025 for FY 2024-25 and similarly every subsequent Financial Year till they are eligible.
- (b) Any applicant who is granted initial sanction in current FY can apply for renewal from subsequent FY between 01st Dec to 31st Mar only by uploading his life certificate.
- (c) After demise of applicant, his widow can apply for initial sanction wef 01st Apr of the next Financial Year.
- (d) RSBs are requested to instruct their Zila Sainik Boards to advise pre-sanctioned beneficiaries (ESM/Widows) under their jurisdiction to submit life certificates online duly signed between **01st Dec & 31st Mar** on KSB Website www.online.ksb.gov.in.

4. In view of the above, all RSBs and ZSBs are requested not to countersign any Life Certificate and not recommend any application for renewal of Penury & 100% Disabled Child, Orphan Grant after lapse of last date for submission of Life Certificate ie 31st Mar. No such application will be accepted & the claim for renewal of said financial year will lapse because the applicant would have failed to apply online within the stipulated period.
